

# Town Manager's Report October 16, 2019

## Administration

New Balance is exploring the option of making a donation to the Town for food pantry development—a contribution that they hope will help reduce food insecurity in our community.
I have a meeting scheduled with a representative of Red Zone Wireless to discuss expanding

internet options in Norridgewock. They offered expanded service, as of October 1.

• I am working with prospective buyers of the small lot on Hotel Street. I have drafted the transfer deed and additional easement. These documents will need legal review before executing.

► The Town Office will be closed on Tuesday, November 5 to staff the election.

## Airport

• All crack sealing was completed to our satisfaction, as well as a patch on the taxilane between hangar rows 600-700.

• We have an underground electrical problem which is causing us to have difficult with the AWOS monitoring system. Staff is working to isolate the issue so that an electrician can come and fix the problem.

## **Public Works**

• DOT has hired a new regional planner, with whom I will be meeting on the 29<sup>th</sup>. If there are any concern areas, please do not hesitate to let me know.

• Roadside mowing began on Monday for our final fall mow.

• I've forwarded the case regarding a right-of-way obstruction and traffic safety concern in the vicinity of 38 Wilder Hill Road, to the municipal attorney. After sending two certified letters, the property is still not in compliance. The attorney will be sending a demand letter before the end of this week. Additionally, notice of right-of-way obstruction has been sent to property owners at 58 Depot Street.

#### Sewer

• The State did not approve our grant application for having to haul waste to Anson-Madison when we were prohibited from spreading. The explanation states that because we were able to take the waste to Madison, we did not qualify. The only qualifying agencies were "facilities where no other practical alternative exists at this time for the management of stored sludge, other than on-site dewatering."
