Host Community Agreement Revisited Increased Rates Negotiated in Town's Favor

Waste Management announced its intention to expand the current facility in Norridgewock; as a part of this plan to expand, the company must negotiate a host community agreement with the Town. Negotiations for the new contract began in May and lasted five months. The Board of Selectmen voted unanimously to sign the revised contract, which means the Town will receive increased host fees as a result of waste being disposed of at Waste Management.

Effective January 1, 2020, the Town's benefit per ton will increase from \$1.70 per ton to \$2.50 per ton. For perspective, in the first nine months of 2019, the Town collected \$484,492.53. With the increased rate, that would have amounted to \$712,489.03. In addition to the base rate, the Town was able to successfully negotiate the inclusion of revenue-generating cover (RGC) into what the Town is paid for. The \$0.50 per ton payment would have amounted to an increase of approximately \$64,120 in the same period.

Rates will increase again when Waste Management has completed the local, state, and federal permitting processes. The final significant increase will take place when the company begins disposing of waste into Phase 14, the expanded portion of the facility. Each year after, host fees will increase by 3% until the per ton rate reaches \$5.00. After reaching \$5 per ton, the per ton host fee will increase by 1% annually.

As with previous agreements, Waste Management will continue to offer the use of the resident transfer station for a total cost of \$1 per year to Norridgewock residents. There were no specific Town projects itemized in the agreement. Legal fees for the cost of negotiations will be reimbursed to the Town, a technical assistance fund remains intact, but the reimbursed funds for Betterment Road maintenance have ceased.

The agreement will last the life of Phase 14 or until another substantive change to the operations takes place, which requires a renegotiation of the current agreement. \star

Tax Bill Survey Returns Community Insights

Working Group Continues with Community Revitalization Plan

A working group of residents and small businessowners in Norridgewock has been collaborating with consultants from Wright-Pierce Engineering to develop a Community Revitalization Plan. This plan will ultimately create a pathway forward for local economic development, giving extraordinary consideration to the positions of stakeholders in Norridgewock– primarily residents and taxpayers.

As a part of this development plan, a survey was mailed out with all tax bills to seek feedback with regards to Town priorities, consumer demand, market opportunities, and what the people of Norridgewock see as the best path forward for revitalization. In addition to the survey that was delivered in tax bills, the Town was grateful to New Balance for their support of a survey customized for New Balance employees. This allowed the working group to gather a perspective of the over-300 employees who come to work in downtown Norridgewock daily.

What did we find out? From the taxpayer survey, responses were compiled. As shown on the right, most of the priorities set forth by respondents focused on enhanced support for local businesses. These responses were further examined at a second public forum where residents were given eight dots and asked to

rank projects/priorities based on their importance. This project was interactive and created an enhanced level of priority within the initial findings.

An interesting component of the survey asked respondents what new businesses one would like to see (new or more of) in the community. Top responses were: hardware store, restaurants, drugstore, and fitness center. While these aren't exclusionary, the list provides insight as to potential demand within the local market.

Where do we go from here? The consulting firm, Wright-Pierce, is working to analyze the information and provide suggestions to the Town as to how we move forward. They will be identifying priority projects and connecting the community with various funding sources to assist in completing projects. The timeline goal is to solidify the plan for the upcoming budget season so that taxpayers may be able to consider initial proposals at the 2020 Town Meeting. Already considered for funding has been lighting upgrades in the downtown area to install more current lighting options, while converting lights to the more efficient LED style. \star
