

BOARD OF SELECTMEN MEETING MINUTES APRIL 18, 2018 6:00 PM

Attendance: Chairman Ronald Frederick, Selectmen Sallie Wilder, and Joshua Chartrand. Town Manager Richard LaBelle, Office Clerk Sharon Dodge, Bookkeeper Peter Lyman. Also present for all or part of the meeting were Charlotte Curtis and Joseph "Skip" Viles. Absent: Vice Chairman James Lyman and Selectman Matthew Everett.

3. Review/Approve Minutes of April 4, 2018

Selectman Wilder made a motion to approve the minutes of April 4, 2018. Seconded by Selectman Chartrand. Motion Passed.

4. Selectmen's Reports

Selectman Chartrand stated that he recently traveled Burrill Hill Road and believes that the road should be considered near the top of the road priority list. The road is in poor condition on the southern end, near Route 139.

Chairman Frederick received a call from Tim Rogers about hosting a concert this summer. Chairman Frederick referred Mr. Rogers to the Planning Board in order to observe the process under the Mass Gathering Ordinance.

Selectman Chartrand made a motion to contract with York's Lawn Care for the 2018 townowned property maintenance contract, in the amount of \$40,000. Seconded by Selectman Wilder. Motion Passed.
