6. Discussion/Action on October 7, 2020 General Warrant #19

Deputy Chief Pineo stated that the fire department has been getting water from Poland Spring for many years and that if Public Works will be picking up water in Kingfield; the Department would appreciate getting an extra pallet.

9. Discussion/Action on Fire Unit 24, New Aluminum Body

Grant amount is up to \$4,500 (25%) with an additional 25% available funding for consideration with a future application. Seconded by Selectman Wilder. MOTION PASSED.
