Fire Captain Todd Pineo spoke regarding some initial concerns and policy decisions that need to be determined prior to the Town setting up a cost recovery program. Those in attendance are in agreement that the program would be beneficial when certain concerns are resolved.

Selectman Everett made a MOTION to recommend the proposed Fire Department budget of \$115,937.60. Seconded by Selectman Chartrand. MOTION PASSED.

Selectman Everett made a MOTION to warrant an article for 2020 Town Meeting to seek the funding for two full-time firefighters to start no earlier than July 1, 2020, to be voted on by referendum. Seconded by Selectman Chartrand. MOTION PASSED.

Selectman Wilder made a MOTION to recommend the Library Trustees' proposed 2020 Library budget for 2020. The MOTION FAILED for lack of a second.

Selectman Everett made a motion to recommend the Town Manager's request for the proposed 2020 Library budget. Seconded by Selectman Chartrand. MOTION PASSED, 3-1 (Frederick, Chartrand, Everett in favor; Wilder opposed).
